The Farmers Market will be on Thursdays, from June 3rd through September 30th, from 4:00pm to 7:00 pm, on Green Street in downtown Tehachapi. This will be a nineteen week season.

There is no commission to be paid on your sales.

Producers are responsible for their own signage within the allotted space in compliance with new state law: Farm's name, County of production, Certified Producer certificate number, and state:

"we only sell what we grow"

Producers are also responsible for any Kern County permits as required by that agency. Please use sandbags or alternate means to anchor your canopies or free-standing signs.

NOTE: No vehicles will be permitted on or off the location during market hours.

The event always draws a crowd to Historic Downtown Tehachapi. We are committed to providing a wide selection of agricultural products to those citizens and an additional sales venue for our local growers. As always, you may park your produce truck near your space.
